RISK FACTORS INCLUDE EXPOSURE TO VIOLENCE, LACK OF INCOME, LACK OF ACCESS TO HEALTHY FOOD, SAFE HOUSING, AND QUALITY HEALTH CARE. FOOD INSECURITY HAS INCREASED IN MASSACHUSETTS BY 71% OVER THE PAST DECADE. OUR CORE MISSION IS TO RESPOND TO THIS PUBLIC HEALTH CRISIS THROUGH OUR HEALTH MEALS PROGRAM AND OTHER CRITICAL SUPPORTIVE SERVICES.

MANY WOMEN ARE SURVIVORS OF DOMESTIC VIOLENCE, SEXUAL ASSAULT, AND STREET VIOLENCE. THE FY '16 GUEST SURVEY SHOWED THAT 80% OF RESPONDENTS HAVE EXPERIENCED DOMESTIC VIOLENCE.
